Team Cyan Remote Learning 25th March-1st April


Dear Parents and Carers,

Remote learning will take place for all in Team Cyan between Thursday 25th March and Thursday 1st Arpil and will be delivered via the Teams portal.

Children will have Maths (10 am), English (11.30 am) and Topic (1.30pm) live teaching input with set activities to complete afterwards.

Below are steps outlining how to access your child's learning:

- Log on to your child's Microsoft Office 365 account. Their user name and password can be found on your MCAS app. For a guide to how to find your login details please see the end of this letter. If you cannot find your child's log in details please e mail Mrs Cheshire.
- Click on Microsoft Teams.
- In order to watch a live lesson, click on the **calendar tab** on the left hand side of Teams. Here you will see the scheduled live sessions. Click on the **one about to take place** and hit **'Join'**. Please ensure you **microphone is switched off**, otherwise the background noise can be distracting.



• If you are not able to watch live and want to watch a lesson that has previously taken place, you need to log in to Teams, click on the button that says **Teams** on the left hand side, click on your child's class and click on the **'posts'** button.


