Dear Parents and Carers of Year 6,

Please find an outline below of the application process for secondary schools:

## **Secondary School Applications**

- Schools are holding their open events now and we encourage you to view a range of schools before completing the application form
- General information from Kent on the process can be found here: <https://www.kent.gov.uk/education-and-children/schools/school-places/secondary-school-places#tab-1>
- Start applications here – [www.kent.gov.uk/ola](http://www.kent.gov.uk/ola) - you will need to set up an account and enter your details etc. – applications are made online. You can go in and out of the form before submitting.
- Application window is open now – deadline for applications is 2nd November (please make sure you do press submit before this date).
- Find out about additional entry requirements for some schools (e.g. church affiliation) and also their over-subscription criteria (how schools decide on ranking for waiting list places etc.)

## **Kent Test Results**

- These are due for parents on the 15<sup>th</sup> October
- At this point, the result of the test is final
- If your child has not been successful in the test, you must go through the process to obtain a high school place for your child and then appeal for a grammar school next March (see below!)

## **Naming schools on the application form**

- The form allows you to name four choices of school
- If your child has not been successful in the Kent Test and you intend to appeal for a grammar school place in March, name three high schools with your fourth being the grammar you want to appeal for. This signposts your intention to appeal.
- Kent have asked me to make it clear that demand for grammar school places in Thanet can be high and so getting through the Kent Test will not always guarantee a place at a grammar school.
- I strongly recommend using all four of your choices on your form. If you name fewer, there is a risk of not obtaining a place at a school on your list and the Local Authority will then allocate you a place at a school where there is space. This may be a school that you do not want your child to attend.

## **How School Places are offered**

- Schools apply their admission criteria to rank applicants
- Kent then offers a place by matching this ranking to school choices on your list
- If you do not rank highly enough for any of the schools on your list, Kent will allocate you a school place that is not on your list
- **This is why it is very important to use all of your choices**

- National offer day is 1<sup>st</sup> March – you will receive an email with a school offer after 4pm (and the offer will be sent by 1<sup>st</sup> class post)

### **What happens after 1<sup>st</sup> March?**

- Happy with the school offer? Accept the place by 15<sup>th</sup> March – schools will then be in touch
- Unhappy with the school offer? **Please still accept the place you have been given so that your child has a school to go to in September**
- Paperwork for appeals and waiting list requests will be sent by post with your school offer
- You can appeal for a school and also ask to be placed on a waiting list for a school
- Waiting list requests must be returned by 15<sup>th</sup> March. Schools will be in touch if they can offer a place (this can happen right up until the summer holidays).
- If you wish to make an appeal for a school place, these must be lodged by 13<sup>th</sup> April

### **Making an appeal**

- This should be based on which school you believe to be the most suitable environment for your child
- This is a parental appeal – we can provide supporting letters
- Appeal evidence is reviewed by a panel
- Appeals are usually held in May / June with decisions made shortly afterwards (the time between March and June does mean it is a significant time to wait for a final decision)

### **In July 2027:**

- Schools will hold transition days for new Year 7 children
- Staff may also visit children at Chilton
